# HOMOLOGATION CERTIFICATE

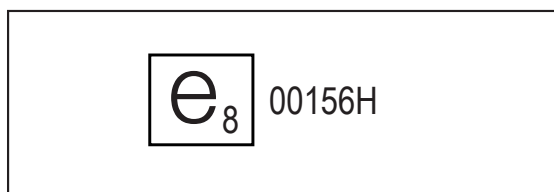

The collaboration with Zard's R&D department further allows each MPRDS Exhaust to perform enriched by a deep bass racing tone giving the pleasure to ride street legal.
